Opinions (or Warnings) Worth Noting

Judge John Facciola wishes the parties would play nice. "There is a new sheriff in town – not Gary Cooper, but me." The Court ordered that the parties cease the "filing of forty-page discovery motions accompanied by thousands of pages of exhibits" and the parties will make "genuine efforts to engage in the cooperative discovery regimen contemplated by the Sedona Conference Cooperation Proclamation." *Tadayon v. Greyhound Lines, Inc.*, 2012 U.S. Dist. LEXIS 78288, 15-17 \* (D.D.C. June 6, 2012).

Judge Shira Scheindlin (of *Zubulake* and *Pension Committee* fame) dealt with adequacy (or not) of the government's searches under FOIA in determining whether it "failed to conduct any searches of the files of certain custodians who were likely to possess responsive records" and whether it "established that the searches that they did conduct were adequate." Judge Scheindlin sounded a bit weary in her conclusion: "This litigation, filed more than two years ago, has already engendered four judicial

opinions - now five." Remember Rule #1, people? Repeat after me: "Don't - Make - the -Judge - Mad!" Nat'l Day Laborer Org. Network v. United States Immigration & Customs Enforcement Agency, 2012 U.S. Dist. LEXIS 97863 (S.D.N.Y. July 13, 2012).

U.S. Magistrate Judge Paul S. Grewal, in granting plaintiff's motion for an adverse inference jury instruction, found that defendant, although put on notice of possible litigation and after having sent its employees a litigation hold letter, failed to suspend its email auto-delete function. This resulted in the destruction of highly relevant ESI. In granting the spoliation order, Judge Grewal noted that the defendant had failed to suspend the same auto-delete feature in a different court case seven years earlier. Apple Inc. v. Samsung Elecs. Co., Ltd., 2012 U.S. Dist. LEXIS 103958, 12-13 (N.D. Cal. July 24, 2012).


